Subject: EUCG Membership Policy Agreement

To Whom It May Concern:

- Abide by all EUCG, Inc. membership By-laws, Standards of Integrity and other policies of the EUCG.

There are times when either EUCG itself or a member may be compelled by law, subpoena, civil investigative or regulatory demand, or similar process to turn over Information to a governmental agency or to a court. In the event that EUCG itself or a member is advised by its legal counsel that it is compelled to turn over Information, EUCG or the member (as applicable) may disclose Information without violating the terms of this letter agreement or any other policy of EUCG, provided that: (i) if the member is compelled to turn over Information, the member provides EUCG with prompt notice of such obligation together with the content of the proposed disclosure as far in advance of its disclosure as is reasonably practicable, and (ii) if EUCG is compelled to turn over Information, EUCG provides all members whose data, documents, reports or other information is contained in the Information being disclosed with prompt notice of such obligation together with the content of the proposed disclosure as far in advance of its disclosure as is reasonably practicable, so that in the case of (i) or (ii) the non-disclosing party may seek to obtain a protective order or other appropriate remedy in order to limit such disclosure, all at the non-disclosing party's expense. In the case of such event, the disclosing party agrees to reasonably cooperate with and not oppose any action by the non-disclosing party to limit such disclosure. The disclosing party may disclose only that portion of the Information as it is advised by its legal counsel that it is required to disclose.

- Ensure that (co name): \_\_\_\_\_ adheres to the requirements that maintain its status as a 'member in good standing' as defined in the By-laws.
- Maintain as confidential and not disclose for a period of ten (10) years after receipt by the member any EUCG surveys, data, documents, reports or any other information (the "Information") produced or acquired during and after my active participation in the EUCG.
- Follow EUCG Policy and process for Data Release, prior to the release of any EUCG information in any form to agencies or persons outside of this member company.
